

## Prize Draw - Terms and Conditions

### Promotor

1. The Promotor of this prize draw is Manchester Airport Plc (registered in England and Wales under company number 01960988 and with its registered address as Level 5 Town Hall Extension, Albert Square, Manchester, England, M60 2LA).

### Prize

2. By entering this prize draw, you are in with a chance of winning either a free lounge visit, or a free car parking voucher for use during your next visit to Manchester Airport! ("**Prize**"). Once notified, the winner will be able to choose their preference between a lounge visit and car parking and will be provided with a voucher that will enable them to book their car parking or lounge visit on our website.
3. The Prize is not negotiable or transferable and no cash alternative will be offered.
4. The Prize is subject to the terms of conditions of our lounges or car parking (as applicable. For lounges this means that it will only cover a maximum of 6 persons. The car parking voucher is for a maximum of 2 weeks and may only be used once.
5. The lounge visit may be booked in either our 1903 or Escape lounges at Manchester Airport, subject to availability in the terminal from which you are flying and at the time/date of your journey.
6. The car parking must be booked via our website and will only apply to our on-site car parks. It is subject to availability based on the terminal from which you are flying and at the time/date of your journey.
7. The Prize shall be given in the form of a discount code.
8. The discount code will need to be redeemed within six months of creation and may only be used in respect of bookings within the twelve months following its creation. If you do not book within this six month period, the discount code will expire and you will no longer be able to use it.

### How to enter

9. This prize draw will run from 00:01 on 01/02/2026 ("**Opening Date**") until 23:59 on 01/10/26 ("**Closing Date**") inclusive.
